Appendix L – Public and Agency Review of the Draft EA

Public Involvement Details

A public notice (found in this appendix) was advertised in a local newspaper explaining that the Draft Short Form Environmental Assessment (EA) was available for public review and comment and included directions on how to provide comments to the project team and request a public hearing.

To allow the public a chance to thoroughly review the Draft Short Form EA, the document was available for 31 days prior to the closing of the commenting period. Physical copies of the Draft Short Form EA document were available for public review at the West Michigan Regional Airport (Airport) Administration Office during normal business hours and an electronic copy was available on the Airport's website.

Summary of Public Comments and Reponses

No public comments were received.

Summary of Agency Comments and Responses

Correspondence from six agencies was received on the Draft Short Form EA and is included below:

City of Holland

The City provided a letter that included four comments. These comments are included below and the letter is provided later in this appendix.

1. The proposed improvements fall within the jurisdiction of the Tulip Inter-County Drain Board (Board), so separate approval is required from that Board as well as the City of Holland (City) for its stormwater ordinance requirements. The Board will not permit additional impervious surfaces as proposed without mitigation improvements.

<u>Airport Response</u>: Comment noted. The Final Short Form EA has been revised to include these approvals for stormwater ordinance requirements, as well as reference to the needed mitigation improvements. These edits were made in **Section 3a**. **Surface Waters**.

2. The proposed improvements will require some large-diameter storm sewer work.

<u>Airport Response</u>: Comment noted. Coordination will take place between the City and the Airport prior to final design.

3. The improvements as proposed would eliminate the possibility of connecting the end of Geurink Blvd. with the end of Regent Blvd. to the north, which has been discussed as a possibility in the past and is included in the WMRA Airport Layout Plan (ALP). The City wants to retain the ability to connect these two streets in the future and may be willing to approve a different location for the connector.

<u>Airport Response</u>: Comment noted. The Airport will coordinate with the City regarding the desired street connections. However, no changes to the project area are expected.

4. Public water and sanitary sewer lines bisect the subject property and if easements do not exist for those utilities, they will be required. Any future buildings/structures would not be permitted within the easement areas. There maybe a possibility to move these utilities, but the Holland Board of Public Works (HBPW) would need to approve the move.

<u>Airport Response</u>: During final design the Airport will coordinate with the City regarding the need for easements and the location of existing utilities. These requirements were added to the Final Short Form EA in **Section 7**, **Permits.**

City of Zeeland

The City Manager responded that they had no comments on the Draft Short Form EA.

• Michigan Department of Natural Resources

A representative from the Michigan DNR responded that they had no comments.

Environmental Protection Agency (EPA)

EPA's NEPA program is in receipt of Mead & Hunt's email requesting review of a Draft Supplemental EA for the proposed North Hangar Taxilane Area at the West Michigan Regional Airport (BIV or Airport) in Holland, Michigan. At this time, due to staffing constraints, EPA will not be reviewing or providing comments on the documents submitted. However, please continue to send us NEPA documents for review. We would appreciate having a minimum of 30 days to review and provide comments on EAs.

• Fishbeck - on behalf of the Allegan County Drain Commissioner

A representative from Fishbeck provided a Tulip Intercounty Drain (Tulip) Policy Review in response to the request for comments on Draft Short Form EA. This document is included later in this appendix, and its findings are provided below:

Upon review, no significant impacts to the Tulip have been identified presuming the site will be designed to meet the requirements of the City of Holland Stormwater Ordinance and the Tulip Watershed Policy Statement.

<u>Airport Response</u>: The Final Short Form EA in **Section 3a. Surface Waters** has been revised to include compliance with the City of Holland stormwater ordinance requirements.

The draft Short Form EA should be updated to include the most recent FEMA map that shows the influence of the 100-year floodplain. Fill within the Tulip floodplain must be mitigated under the Tulip Watershed Policy Statement. A Michigan Department of Environment, Great Lakes and Energy (EGLE) permit may also be required.

<u>Airport Response</u>: Appendix K Water Resources of the Final Short Form EA has been revised to include the most recent FEMA map. Section 2. Floodplains has been revised to include the requirement to mitigate floodplain impacts. Fill placed within the regulated floodplain will be mitigated with a compensating cut at a 1:1.25 ratio, as outlined in the Tulip Watershed Policy Statement.

• Michigan Department of Environment, Great Lakes, and Energy (EGLE)

EGLE provided two separate responses. First, an email message was sent addressing floodplain impacts for the project location (found later in this appendix). Second, a formal letter (also found later in this appendix) providing five comments on the Draft Short Form EA. The comments are found below:

Email message addressing the floodplain impacts:

Thank you for passing along the draft short form EA for the proposed hanger and taxilane expansion at West Michigan Regional Airport. The assessment states that there will be no impacts to the 100-year floodplain of North Branch Macatawa River, but the FEMA maps appear to intersect with the eastern portion of the project (see attached Firmette for the project location). If you believe the work is outside the regulated floodplain, please provide detailed maps and drawings showing that the work is outside the 100-year floodplain or above the elevation of 669.7-feet.

<u>Airport Response</u>: Section 2. Floodplains of the Final Short Form EA has been revised to state that there will be minor impacts to the 100-year floodplain and a Part 31, Floodplain Permit will be completed prior to earth moving activities.

The following five comments were included in the formal letter:

1. The project, as proposed in the EA, will NOT require a permit under Part 301, Inland Lakes and Streams, and Part 303 Wetlands Protection of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA). The existing stormwater drainage ditches were constructed in upland, so any impacts to them will NOT be regulated under Part 303.

<u>Airport Response</u>: Comment noted.

2. If the project intersects with the 100-year floodplain of the north branch Macatawa River and work occurs below the elevation of 669.7-feet, then a permit will be required under the Floodplain Regulatory Authority of Part 31, Water Resources, of the NREPA. The FEMA FIRMette for the area shows the floodplain extending throughout the detention pond and the northeastern corner of the property.

<u>Airport Response</u>: Section 2. Floodplains of the Final Short Form EA has been revised to include the need for a permit under the Floodplain Regulatory Authority of Part 31, Water Resources.

3. A National Pollution Discharge Elimination System permit will be required for storm water discharges associated with construction activities in accordance with Rule 2190 promulgated in accordance with Part 31, Water Resources Protection, of the NREPA.

<u>Airport Response</u>: Comment noted. This need for this permit was included in the Draft Short Form EA.

4. A permit will be required under Part 91, Soil Erosion and Sedimentation Control, of the NREPA. Part 91 permits are generally issued by the county or, in some instances, the local municipality.

<u>Airport Response</u>: Comment noted. This need for this permit was included in the Draft Short Form EA.

5. A review of our database indicates no occurrences of State and/or Federal Threatened and Endangered species in the project location. However, your project location is within the range of the Northern Long Eared Bat and Indiana Bat, which are considered potentially present wherever suitable habitat exists within their range. You should consult with the Fish and Wildlife Service prior to preforming work or applying for permits.

Airport Response: Comment noted.

Fishbeck has completed a review of the draft "Short Environmental Assessment Form for Airport Development Projects" (Short Form EA) and accompanying Appendix K for the Airport North Hangar Area Taxilane prepared for the Michigan Department of Transportation Office of Aeronautics by Mead & Hunt, Inc. Our review was completed in response to the Notice of Availability (NOA) letter from Mead & Hunt, Inc. addressed to your office and dated July 18, 2023. Our review is limited to the preliminary stormwater management plan for the site in accordance with the Watershed Policy Statement for the Tulip Intercounty Drain Drainage Board.

Proposed Site Improvements




Figure 1 - Proposed Site Improvements

From the Short Form EA: The Airport owns a 17.1-acre area north of the existing terminal building currently without aviation infrastructure. To meet the needs of existing and future users, the Airport is planning to construct the necessary infrastructure to provide access to this area. Proposed future development includes private and corporate hangars, taxilanes, taxilane connectors, apron expansion, construction grading, lighting, fencing, utilities, and site restoration (Figure 1).

Major stormwater improvements include enclosing approximately 1,300 lineal feet of drainage ditch and expanding the existing stormwater detention basin to accommodate an additional 5.43 acres of impervious area.

Site Location and Stormwater Management Requirements

The site is located in the Tulip Intercounty Drain (Tulip) Drainage District on the west side of M-40 in Allegan County. Under the Tulip Watershed Policy Statement, stormwater detention is required for flood control. The site will also need to meet the additional stormwater requirements in the City of Holland Stormwater Ordinance.




Figure 2 - FEMA Flood Hazard Map

The existing detention basin and easterly portion of the site is located within the Tulip floodplain, which has also been mapped by the Federal Emergency Management Agency (FEMA). The most recent effective map is dated June 21, 2023. The FEMA map shows an elevation of 669.7 feet for the 1-percent chance (100-year) floodplain at this location (Figure 2).

The Tulip Policy Statement requires that any fill placed within the 100-year floodplain (or lost floodplain) be mitigated with compensating cut at a 1:1.25 ratio. The compensating cut must allow for the Tulip flood flow to move freely in and out of the excavated floodplain area.


